Additionally, TISDALE was terminated after engaging in 20 conduct involving prejudice or discrimination against a person on the basis of race, 21 color, and/or national origin. Such misconduct subjects TISDALE'S peace officer 22 certification to discipline under RCW 43.101.105(3)(j)(iv), (3)(h), and (3)(k). The 23 circumstances are as follows: 24

Count I

On or about September 22, 2019 and March 31, 2020, TISDALE engaged in conduct that failed to meet the ethical and professional standards of a peace officer; and/or disrupted, diminished, or otherwise jeopardized public trust or confidence in the law enforcement profession; and/or demonstrated an inability or unwillingness to uphold the officer's sworn oath to enforce the Constitution and laws of the United States and the state of Washington. TISDALE did so when he violated the SPD's policies governing professionalism and bias-free policing, including by: (1) engaging in a public dispute with his spouse while intoxicated that required a police response; and/or (2) engaging in a verbal altercation with Puyallup Police Department officers and disrespecting their authority; and/or (3) utilizing profanity, unprofessional language, and making biased statements against fellow officers as well as against unhoused individuals while identifying himself as a member of the SPD; and/or (4) by engaging in the conduct described below in Count II. TISDALE's peace officer certification is subject to discipline under RCW 43.101.105(3)(j)(iv).

AND/OR

On or about March 31, 2020, TISDALE engaged in conduct involving prejudice and/or discrimination based on the basis of race, color, and/or national origin when, in the presence of other SPD employees, he made racially derogatory comments about a civilian, in violation of the SPD's policies against bias-free policing and professionalism. TISDALE's peace officer certification is subject to discipline under RCW 43.101.105(3)(h).
