Chief Bob White Flagstaff PD Retired; Emotional Survival for Law Enforcement is designed to have law enforcement professionals review how the same psychological and physiological states that produce success in the law enforcement operative's professional life, can without awareness and management strategies produce damage in the realm of the personal life. The course looks at the short-term impact on judgment, decision making and reaction time and points out the long-term connection to depression and to presumptive disease development in the areas of Type 2 diabetes, obesity, heart disease and stroke. The goal of the course is to have law enforcement

professionals, in this case specialty investigators, know the warning signs and develop personal lifestyles higher in resilience that reduce risk of emotional and physical damage. (Spouses are encouraged to attend)

DEA Deputy Chief of Operations, Matt Donahue will provide an overview of current illicit drug production and smuggling trends in Mexico, as well as the status of major Mexican transnational criminal organizations directly impacting the availability of drugs in the United States.

Targeting the Sinaloa Cartel: DEA GS Victor Vazquez was the lead US agent-in-charge of targeting the highest-level members of La Familia Michoacan and Los Caballeros Templarios to include Consolidated Priority Organizational Targets (CPOTs) Nazario Moreno-Gonzalez aka Chayo, Jesus Mendez-Vargas aka Chango Mendez, Servando Gomez-Martinez aka La Tuta, Enrique Plancarte-Solis aka Kike and Sinaloa Cartel CPOTs Ismael Zambada-Garcia, and Joaquin Guzman-Loera aka Chapo. Victor will brief events from January 2012 to June 2019 providing fascinating insight into the cases that took down these targets.
