### **MAN HUNT INVESTIGATIONS & RANSOMWARE**

Presenter: Retired FBI Supervisory Special Agent Vincent Dalfonzo

Manhunt Investigations – The presentation will focus on an overarching communication/negotiation strategy to be considered in a law enforcement manhunt. This method can be used in both a lengthy, complex manhunt where the subject's location is unknown and has been extremely violent, or in a manhunt where the subject has committed a crime and law enforcement has a general idea of their location and is seeking the cooperation of the community in apprehension of subject. Case studies will be used to highlight the strategy.

Ransomware – The presentation is designed to provide a general overview of ransomware attacks and how hostage negotiators can benefit investigators. It will illustrate these principles through a real-world case study involving hostage negotiators. Finally, it will provide best practices for coordination of resources, contingency planning, and strategic integration.

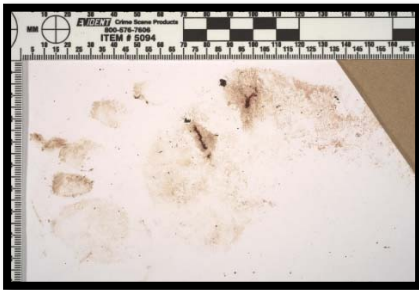
### **FORENSIC TESTIMONY TECHNIQUES**

What would you expect to hear from forensic practitioners when asked what their least favorite job duty is? By far, hands down, everyone says testifying! Being an expert witness is daunting for most forensic practitioners. This workshop is designed to provide the necessary skills, tips, and confidence building tools to help you shake off

those nerves and provide clear and concise testimony in any courtroom. Angela will primarily focus on latent print and forensic testimony; however, this workshop is suitable for anyone in the forensic and law enforcement disciplines. Angela will share her personal experiences of testifying throughout her career, to include several high profile cases, one of which includes the processing and comparison of a bloody foot impression from a homicide and a 32-year-old cold case solved using genetic genealogy. She will talk about her very first court appearance, to her most recent trip "to the hot seat." She will discuss best approaches for testifying after errors and how to answer questions regarding recent publications, such as the AAFFS, NAS and PCAST reports.

Angela has taken all of her testimony experience and the generic tips and tailored them to create a set of unique methods to abandon testimony fears. By implementing these techniques, the jury and members of the court will see nothing less than a confident, qualified, forensic professional the next time you are on the witness stand. Angela will also reserve time to answer any questions regarding the many roles and disciplines that encompass forensic science and the techniques and services that are available to you to assist in solving crime.
