LESSONS LEARNED FROM COMPLEX DEATH INVESTIGATIONS... YOU CANNOT GO BACK

Presenter: Blood Spatter & Crime Scene Expert Rod Englert

Rod Englert lectures nationally and internationally on many aspects of homicide investigations, including blood pattern analysis, gunshot wounds and trajectory paths, DNA collection, state-of-the-art forensic techniques, courtroom evidence, and officer-involved shootings.

This presentation will focus on evidence at complex death scenes often missed or overlooked. Case studies as examples will demonstrate what can be done to overcome our failures as investigators at a death scene. There will be a focus on recognition of subtle evidence at scenes that can fill in the gaps for a confident reconstruction of the event.

PISTOLS AND CRYSTALS - PART DEUX

Presenter: Sergeant Joshua Zwick, Multnomah County Sheriff's Office







Back by popular demand, Multnomah County Sheriff's Office Special Investigations Unit Detective Joshua Zwick, the lead investigator in a large white gangster case dubbed "Operation White Christmas." This time, Detective Zwick will be talking about a Len Bias case with a twist that resulted in the arrest of 12 suspects, several visits to high-end hotels, and an in custody death.

Detective Zwick will also discuss up to the minute trends in the drug culture, how drugs are currently being smuggled into Oregon and Washington, and how bulk cash is being smuggled out. Detective Zwick will discuss the current opioid crisis, fentanyl in particular, in the northwest and how it should be approached by those in law enforcement.
