## **SYNOPSIS**

This course will provide students with a comprehensive understanding of international and organized crime groups and transnational criminal organizations, with specific emphasis on their criminal activities and how they impact the United States.

They will also be introduced to practical investigative tools to combat the influence and spread of transnational organized crime and their criminal partnerships.
