MEMORANDUM OF UNDERSTANDING Between

The Washington State liquor Control Board

AND

Washington State Criminal Justice Training Commission

CONTRACT NUMBER: K530

1. PARTIES TO THE MEMORANDUM

This Memorandum of Understanding (MOU) is made and entered into by and between the Washington State Liquor Control Board, hereinafter referred to as "WSLCB", and the Washington State Criminal Justice Training Commission, hereinafter referred to as "WSCJTC", pursuant to the authority granted by Chapter 39.34 RCW.

2. PURPOSE

Whereas the people of the State of Washington passed initiative I-502, which authorizes the WSLCB board to regulate and tax marijuana for persons twenty-one years of age and older and whereas RCW 69.50 authorizes the Enforcement Officers of the WSLCB to enforce RCW 69.50, the Uniform Controlled Substances Act, it is in the State's best interest for public safety of all citizens to ensure that the officers of the WSLCB are fully trained by Basic Law Enforcement Academy (BLEA) standards at the WSCJTC and receive the same priority as all general authority jurisdiction officers.

3. PERIOD OF PERFORMANCE

This MOU shall become effective on May 1, 2014 and will expire on April 30, 2019, with the option to extend for additional terms, or unless general authority jurisdiction has been granted, therefore, this MOU will become null and void.

4. STATEMENT OF WORK

The WSCJTC will ensure space is available for four (4) WSLCB Enforcement Officers to attend the next available BLEA training class, which will be no later then September 2014. The WSCJTC will ensure WSLCB receives the same priority as general authority jurisdictions when scheduling future BLEA trainings for WSCLB Enforcement Officers.

5. COMPENSATION

The WSLCB will reimburse the WSCJTC for BLEA training per the current non-mandated agency cost in effect per student, as published per WSCJTC per session

6. AGREEMENT CHANGES, MODIFICATIONS AND AMENDMENTS

This MOU may be changed, modified, or amended by written agreement executed by both parties.

7. APPROVAL

The signatories to this MOU represent that they have the authority to bind their respective organizations to this MOU.
