## **Description**

Investigator 2

The Department of Social and Health Services, Office of Fraud and Accountability, has an opportunity for a Fraud Investigator to conduct and resolve complex administrative investigations of public benefit fraud in our Fraud Early Detection program.

You'd be working out of either the Moses Lake or Spokane Community Service Office, which includes out-of-office fieldwork.

Your investigations will involve all public assistance programs administered by DSHS, including: Temporary Assistance for Needy Families, Medical Assistance, Supplemental Nutrition Assistance Program, Electronic Benefits Transfer, and Childcare. Allegations investigated include household composition and unreported income among other situations that affect eligibility for public assistance programs.

#### Some of what you'll do

- Conduct and resolve complex civil or criminal welfare fraud investigations/Fraud Early Detection investigations
- Identify, gather, and preserve physical and documentary evidence
- Conduct witness and client interviews in the community to verify statements; conduct surveillance
- Analyze evidence and criminal violations via database searches, fieldwork, and interviews to identify leads; research and interpret records, and evaluate the reliability, credibility, and admissibility of evidence
- Attend administrative or court proceedings

#### Who should apply

Professionals with 3 years of experience as an investigator with a criminal justice government agency or private organization, or other directly allied field. (Two years of related college-level coursework may be substituted for experience.)

Or

One year of experience as an Investigator 1.

#### **Desired**

- Experience as a Public Benefits Specialist/Financial Services Specialist
- Experience conducting interviews, analyzing documents, verifying information, and making eligibility determinations for public assistance welfare benefits or locating non-custodial parents for child support enforcement
- Knowledge of regulations and policies related to public assistance eligibility, including food assistance, medical assistance, general assistance, and childcare assistance
- Knowledge of methods, principles, standards, and techniques of investigations; knowledge of interview techniques, rules of evidence, chain of custody of evidence, laws of search and seizure, Miranda Warning, and the Health Insurance Portability and Accountability Act
- Ability to use verbal de-escalation techniques when necessary
- Ability to safely make field contacts with subjects and witnesses, and conduct surveillance to further investigations

We have a selection of health and retirement plans, paid leave, staff training and other compensation benefits that you can mix and match to meet your current and future needs.

#### Read about our benefits:

The following information describes typical benefits available for full-time employees who are expected to work more than six months. Actual benefits may vary by appointment type or be prorated for other than full-time work (e.g. part-time); view the job posting for benefits details for job types other than full-time.

**Note:** If the position offers benefits which differ from the following, the job posting should include the specific benefits.

#### **Insurance Benefits**

Employees and their families are covered by medical (including vision), dental and basic life insurance. There are multiple medical plans with affordable monthly premiums that offer coverage throughout the state.

Staff are eligible to enroll each year in a medical flexible spending account which enables them to use tax-deferred dollars toward their health care expenses. Employees are also covered by basic life and long-term disability insurance, with the option to purchase additional coverage amounts.

To view premium rates, coverage choice in your area and how to enroll, please visit the <u>Public Employees Benefits</u> <u>Board (PEBB) website</u>. The <u>Washington Wellness</u> program from the Health Care Authority works with PEBB to support our workplace <u>wellness programs</u>.

<u>Dependent care assistance</u> allows the employee to save pre-tax dollars for a child or elder care expenses.

Other insurance coverage for auto, boat, home, and renter insurance is available through payroll deduction.

The Washington State Employee Assistance Program promotes the health and well-being of employees.

#### **Retirement and Deferred Compensation**

State Employees are members of the Washington Public Employees' Retirement System (PERS). New employees have the option of two employer contributed retirement programs. For additional information, check out the <u>Department of Retirement Systems</u>' web site.

Employees also have the ability to participate in the <u>Deferred Compensation Program</u> (DCP). This is a supplemental

retirement savings program (similar to an IRA) that allows you control over the amount of pre-tax salary dollars you defer as well as the flexibility to choose between multiple investment options.

### **Social Security**

All state employees are covered by the federal <u>Social Security</u> and Medicare systems. The state and the employee pay an equal amount into the system.

### **Public Service Loan Forgiveness**

If you are employed by a government or not-for-profit organization, and meet the qualifying criteria, you may be eligible to receive student loan forgiveness under the <u>Public Service Loan Forgiveness Program</u>.

#### **Holidays**

Full-time and part-time employees are entitled to paid holidays and one paid personal holiday per calendar year.

**Note:** Employees who are members of certain Unions may be entitled to additional personal leave day(s), please refer to position specific <u>Collective Bargaining Agreements</u> for more information.

Full-time employees who work full monthly schedules qualify for holiday compensation if they are employed before the holiday and are in pay status for at least 80 nonovertime hours during the month of the holiday; or for the entire work shift preceding the holiday.

Part-time employees who are in pay status during the month of the holiday qualify for the holiday on a pro-rata basis. Compensation for holidays (including personal holiday) will be proportionate to the number of hours in pay status in the month to that required for full-time employment, excluding all holiday hours. Pay status includes hours worked and time on paid leave.

#### Sick Leave

Full-time employees earn eight hours of sick leave per month. Overtime eligible employees who are in pay status for less than 80 hours per month, earn a monthly proportionate to the number of hours in pay status, in the month to that required for full-time employment. Overtime exempt employees who are in pay status for less than 80 hours per month do not earn a monthly accrual of sick leave.

Sick leave accruals for part-time employees will be proportionate to the number of hours in pay status, in the month to that required for full-time employment. Pay status includes hours worked, time on paid leave and paid holiday.

### **Vacation (Annual Leave)**

Full-time employees accrue vacation leave at the rates specified in <u>WAC 357-31-165(1)</u> or the applicable collective bargaining agreement (CBA). Full-time employees who are in pay status for less than 80 nonovertime hours in a month

do not earn a monthly accrual of vacation leave.

Part-time employees accrue vacation leave hours in accordance with <u>WAC 357-31-165(1)</u> or the applicable collective bargaining agreement (CBA) on a pro rata basis. Vacation leave accrual will be proportionate to the number of hours in pay status, in the month to that required for full-time employment.

Pay status includes hours worked, time on paid leave and paid holiday.

As provided in <u>WAC 357-58-175</u>, an employer may authorize a lump-sum accrual of vacation leave or accelerate the vacation leave accrual rate to support the recruitment and/or retention of a candidate or employee for a Washington Management Service position. Vacation leave accrual rates may only be accelerated using the rates established WAC 357-31-165.

<u>Note:</u> Most agencies follow the civil service rules covering leave and holidays for **exempt** employees even though there is no requirement for them to do so. However, agencies are required to adhere to the applicable RCWs pertaining holidays and leave.

#### **Military Leave**

Washington State supports members of the armed forces with 21 days paid military leave per year.

#### **Bereavement Leave**

Most employees whose family member or household member dies, are entitled to three (3) days of paid bereavement leave. In addition, the employer may approve other available leave types for the purpose of bereavement leave.
