Instructors listed with Level 1 Scoped Rifle Instructor active status may or may not be PS Certified Firearms Instructors for WSCJTC (not a required part of RCW or WAC).

[LEOSA Program](#) – As per RCW, any certified handgun instructor in Washington can provide the qualification for LEOSA. Many agencies do in-house LEOSA qualifications for their personnel. The WSCJTC LEOSA Program will only accept LEOSA application packets from active LE Instructors that have completed a WSCJTC firearms instructor course either via the law enforcement program or the Firearms Certificate program within the last three years. ****All PS Certified Firearms Instructors for WSCJTC listed in this directory are eligible to complete LEOSA qualifications.**
