| <p>Per WAC 139-12-030 to maintain status as an IIT qualified lead investigator, candidates must provide proof of successful completion of the prescribed training classes with a minimum of eight hours of training annually. The continued annual training topics include, but are not limited to:</p> <ul style="list-style-type: none"> • advanced homicide investigation techniques; • advanced interviewing and interrogation; • officer-involved shooting investigation; • in-custody death investigation; • excited delirium and positional asphyxia; • bloodstain pattern analysis; • crime scene photography/videography; and • other related training, seminars, and conferences or on-going training as offered by WSCJTC or other training venues on an as available basis. <p>The IIT shall train as a unit at least annually. To review the full WAC click here. IIT lead commanders shall submit this continued training attestation to LETCSA staff at WSCJTC on an annual basis. If an IIT qualified lead investigator received their certification during the calendar year for this attestation, they will not be required to take the annual continued training until the following year.</p> | |
