### The hearing will be held through the Microsoft Teams platform.

- 1. Five minutes before your hearing, click this link: <u>Online Hearing</u>
- 2. You will be asked to join your Teams meeting via browser or Teams app.
- 3. If prompted, allow Teams to use your camera and microphone.
- 4. Please enter your full name when prompted and select "Join Now."
- 5. Wait to be admitted into the meeting by the Judge.

## TO PARTICIPATE BY TELEPHONE ONLY:

- 1. To participate, call **1-866-527-0393** at the time specified above.
- 2. When prompted, enter **444 310 448, followed by the # key**. You are not the Meeting Organizer so do NOT press the \* key if asked to do so.
- 3. You will be placed in the "lobby" awaiting the Judge to begin the event (you may hear "Hold" music).
- 4. Please announce yourself as you join. Make sure your phone has reception and is charged to last the length of the mediation, and that you are in a quiet place where you can hear and be heard clearly.
- 5. If you have problems joining the telephone conference, or if the judge does not join within ten minutes after the Hearing start time, immediately call OAH at (253) 476-6888. If you get disconnected, call back in using the same phone number and access code listed in Steps 1 and 2 above. If you have trouble getting reconnected to the telephone conference, call (253) 476-6888 immediately for help.
