STATEMENT OF CHARGES

11 Respondent.

13 On or about January 23, 2024, GLEN TREJO, a certified peace officer with
14 Granger Police Department (GPD), was discharged or otherwise separated from
15 employment with GPD after he: (1) knowingly made misleading, deceptive, untrue, or
16 fraudulent representations in the practice of being a peace officer; and/or (2) was
17 prohibited from possessing weapons by state or federal law or by a permanent court
18 order after a hearing; and/or (3) interfered with an investigation or action for denial or
19 revocation of certification by the Criminal Justice Training Commission (Commission)
20 by knowingly making a materially false statement to the Commission; and/or
21 (4) interfered with an investigation or action for denial or revocation of certification by
22 the Commission by tampering with evidence or tampering with or intimidating any
23 witness; and/or (5) failed to meet the ethical and professional standards required of a
24 peace officer. Such misconduct subjects TREJO's peace officer certification to
25 discipline under RCW 43.101.105(2)(d); (2)(e); (3)(d)(i), (3)(d)(iii), (3)(j)(iv), and (3)(k).

26 The circumstances are as follows:

COUNT I

Between December 2022 to September 2023, TREJO knowingly made misleading, deceptive, untrue, or fraudulent representations in the practice of being a peace officer when he: (1) he made false or misleading statements to GPD Sergeant David Marks about the nature of TREJO's relationship with a female civilian he met while responding to a call for service; and/or (2) while on duty during an internal investigation, made false and/or misleading statements to Professional Standards Investigator Tony Bennett concerning TREJO's relationship and interactions with this female civilian. After making these false statements, TREJO separated from the GPD on or about January 23, 2024. TREJO's peace officer certification is subject to mandatory revocation under RCW 43.101.105(2)(d).

AND/OR

COUNT II

On or about July 27, 2023, TREJO was prohibited from possessing weapons by state or federal law or by a permanent court order entered after a hearing in Yakima County Superior Court Case #23-2-01692-39. TREJO's peace officer certification is subject to mandatory revocation under RCW 43.101.105(2)(e).

AND/OR

COUNT III

On or about December 11, 2023, TREJO interfered with an investigation or action for denial or revocation of certification by knowingly making a materially false statement to the Commission. Specifically, TREJO falsely told Commission Investigator Aaron Jelcick that he did not: (1) engage in sexual contact with a female civilian while on duty, and/or (2) encourage this female civilian to file a false complaint against former Granger Police Chief Estevan Araguz. TREJO's peace officer certification is subject to discipline under RCW 43.101.105(3)(d)(i).

1 AND/OR

2 **COUNT IV**

3 On or about July 2023, TREJO interfered with an investigation or action for denial
4 or revocation of certification by tampering with evidence or tampering with or
5 intimidating any witness in a matter under review or investigation or otherwise before
6 the Commission. Specifically, TREJO: (1) encouraged a female civilian to file a false
7 complaint against former Granger Police Chief Estevan Araguz in an attempt to thwart
8 the Commission's investigation into TREJO's misconduct; and/or (2) went to this
9 civilian's workplace in an attempt to coerce her not to cooperate with any investigation
10 into his misconduct. TREJO's peace officer certification is subject to discipline under
11 RCW 43.101.105(3)(d)(iii).

12 AND/OR

13 **COUNT V**

14 Between July 2022 and January 2024, TREJO engaged in conduct that failed to
15 meet the ethical and professional standards required of a peace officer; disrupted,
16 diminished or otherwise jeopardized public trust or confidence in the law enforcement
17 profession, and/or demonstrated an inability or unwillingness to uphold the officer's
18 sworn oath to enforce the Constitution and laws of the United States and the state of
19 Washington when he: (1) engaged in the conduct described in Count I and/or II and/or
20 III and/or Count IV; and/or (2) engaged in sexual contact with the above-mentioned
21 female civilian while on-duty and/or in public; and/or (3) made false or misleading
22 statements under oath during a protection order hearing in Yakima County Superior
23 Court Case #23-2-01692-39; and/or (4) harassed and/or intimidated the
24 above-mentioned female civilian; and/or (5) was insubordinate when placed on
25 administrative leave, to the extent that his Chief had to physically prevent him from
26 leaving the building with his department-issued equipment. TREJO's peace officer
certification is subject to discipline under RCW 43.101.105(3)(j)(iv).

1 AND/OR

2 **COUNT VI**

3 On or about January 23, 2024, TREJO was discharged or otherwise separated
4 from employment with the GPD after engaging in the misconduct described in Counts
5 III, IV, and V. TREJO's peace officer certification is subject to discipline under
6 RCW 43.101.105(3)(k).
